WITH AGRO ENTERPRISES GAGAUZ YERI

Comrat State University, hereinafter referred to as the University represented by the rector, Doctor of Sciences Serghei ZAKHARIA., Acting on the basis of the Charter, on the one hand, and agricultural enterprises for the production and processing of milk:

1. FABRICA OLOI PAK S.R.L. (SANA), represented by director Maria AKBASH
2. S.R.L "DOKSANCOM" SC, represented by the director Igor AKBASH
3. S.R.L.GEXIMSUD ", represented by director Grigory GERASIMOV

have entered into this Agreement as follows:

1. Subject of the agreement

The subject of the Agreement is the cooperation of the Center of Agrobiotechnology of the University with agricultural enterprises of the Region for the production and processing of milk. Cooperation is carried out within the framework of the UNI-Clad project to create an agro-industrial cluster and an Expert Center on the basis of a signed agreement in the following areas:

1. In the field of educational activities:

- training of agricultural specialists of the second cycle on the basis of agricultural

Faculty of Technology, KSU;

-development of special modules for undergraduates such as: statistics, project development, econometrics, modules aimed at pressing problems: climate change, COP 21 commitments, food security, poverty alleviation;

-holding public lectures by representatives of agro-industrial enterprises in order to popularize agricultural specialties in the region;

-participation of representatives of agro-industrial enterprises in the expert assessment of the curricula of the agrarian-technological faculty for the inclusion of relevant disciplines, the study of which will allow graduates to be in demand in the labor market;

-providing students with an opportunity to undergo practical training in agro-industrial enterprises.

2. In the field of scientific activity:

-Carrying out joint activities in the field of agricultural production;

-joint organization and participation in scientific events, conferences, etc.;

-preparation of joint publications;

-conducting research by students of the agrarian-technological faculty on the basis of enterprises' data, followed by writing theses and dissertations.

3. In the field of promoting agricultural enterprises in the region:

-Attracting students of the agrarian-technological faculty together with representatives of agro-industrial enterprises in holding meetings with graduates of Gagauz Yeri lyceums to popularize agricultural specialties;

-organization of special trainings, study tours for representatives of business, science and education in order to demonstrate the benefits and build the potential for cooperation within the cluster.

4. In the field of improving the technical base of the University:

-Purchase of laboratory equipment and office equipment for the Faculty of Agriculture within the framework of the "Uni Clad" project.

5. In the field of employment of University students:

-Opportunity for graduates of the agro-technological faculty to find employment at agricultural enterprises that are part of the agro-industrial cluster.

2. Obligations of the parties

2.1. THE UNIVERSITY IS COMMITTED TO:

2.2.1. Provide access for cluster members to the university building in order to organize the events specified in the Agreement.

2.2.2. To assist agricultural enterprises in the dissemination of information for students through the CSU Website, CSU social networks.

2.2.3. Ensure continuous cooperation with representatives of agricultural enterprises by jointly organizing and conducting events related to agriculture.

2.2.4. Information about the work of the Cluster should be reflected on the university website, in social networks on the pages of the University.

2.2.5. Provide the direction of students for practice while undergoing relevant practice in agricultural enterprises that are part of the cluster.

2.2.6. Provide curricula for the implementation of peer review for agricultural enterprises.

2.2.7. Ensure timely receipt of information by students on available vacancies in these enterprises.

2.2.8. To assist in informing students on the conduct of open lectures by specialists of these enterprises.

2.2.9. Provide space for organizing open lectures with students.

2.2.10. Provide information on holding events, agree on the possibility of participation of representatives of agricultural enterprises at events.

2.2.11. Cooperate in filling out applications for the implementation of joint projects in the field of agriculture, in case of bilateral interest in the topic of the project and receiving a grant.

2.2. AGRICULTURAL ENTERPRISES ARE OBLIGED TO:

2.2.1. Participate in an expert assessment to adjust curricula and training programs for specialists, as well as to open promising specialties and specializations.

2.2.2. To take part in scientific and practical conferences, seminars, competitions held on the basis of the University.

2.2.3. Provide the University with the necessary information about available vacancies in order to employ graduates of the University.
