INFORMATION BULLETIN FOR ADMISSION OF FOREIGN STUDENTS TO COMRAT STATE UNIVERSITY

There are 4 faculties at Comrat State University: The Faculty of National Culture, Economics, Law and Agrarian Technology.

The University carries out activities in the field of higher education on the I cycle - Licentiate and on the II cycle - Master's Degree.

Students - foreigners have the opportunity to get more than 8 specialties on the I cycle - Licentiate and more than 6 specialties on the II cycle - Master's Degree.

As part of the Bologna process for the integration of educational systems, student and academic mobility has been activated, thanks to the participation of the university in the projects of the European Commission funds: ERASMUS +, ERASMUS MUNDUS, TEMPUS, DAAD, as well as the American Fulbright program, the mobility of teaching staff and students is possible.

To consolidate knowledge in educational programs at the university, there are: Center for Continuing Education, Center for Information Technologies, Business Center, Innovation Incubator "InnoCenter", Center "Euraxess", Information Center of the European Union, Educational Center for modern technologies for civil servants, Center for initiative youth.

Also, the University has a number of centers for the study of the language and culture of a number of foreign countries, which are open with the assistance of the Embassies of Germany, the USA, Great Britain, Turkey, Azerbaijan, Hungary, Romania, Greece, etc.

There is a student self-government at the university, which represents the interests of students, organizes leisure activities by holding evenings of rest, discos and other events.

There is a comfortable hostel and laboratories at the university, as well as the opportunity to train and restore physical fitness in the sports complex of the university.

The preparatory department at the university was created and exists to prepare foreign students for study at various faculties of the university. The program of the Preparatory Department is designed for 10 months. Students master the Russian language to the extent

that allows them to feel comfortable in Moldova in all spheres of life. The achieved level of the Russian language is more than sufficient to start studying disciplines in their chosen specialty within the framework of the University.

Experience shows that students who have completed training at the Preparatory Department are easier to study in their chosen specialties with the right to choose the language of instruction.

Classes start October 1st. Admission to the Preparatory Department of the University **does NOT require** passing entrance exams.

1. The Preparatory Department of CSU accepts students from far abroad countries and foreign students from the CIS countries.

The tuition fee for the Preparatory Department is 300 US dollars.

2. For accommodation, the living quarters of the dormitory of the Comrat State University are used, at the address: 152 Tretiakov Str., Comrat.

Residential premises of the university dormitory of block type, there are 2 living rooms in it (divided into 2-bed and 4-beds in the room), a bathroom and an entrance hall. The cost of living for one bed (for one resident) is 6000 lei per year. In addition, students of the Preparatory Department mainly use rental housing in the private sector for living, the cost of renting housing varies from 250-350 euros per month (depending on the category of housing).

3. Upon completion of the Preparatory Department, CSU provides admission without setting restrictions on **the following specialties of the I Cycle - Licentiate:**

Upon completion of **the I Cycle - Licentiate at CSU**, foreign students are admitted without establishing restrictions on **the following specialties of the II Cycle - Master's Degree:**

4. For admission to study, foreign citizens are required to submit the following documents:

- A) Diploma of graduation from a secondary school with information about grades.
- B) Passport valid for at least one year from the date of entry into the territory of the Republic of Moldova.
- C) Certificate of no criminal record (certificate from the police), issued by the authorized bodies of the state of permanent residence.
(Important: It is obligatory that the validity period of the criminal record certificate when entering the territory of the Republic of Moldova has not expired. Otherwise, the candidate will need a new document).
- D) A medical certificate confirming the absence of medical contraindications and indicating the negative results of testing for HIV / AIDS.
- E) Medical insurance (international standard) for at least a year.
- F) A copy of the birth certificate, (marriage or name change - for those who are affected).
- G) An extract from a bank account, which confirms the presence of at least 2500 euros on a personal account. The certificate must be valid no more than 10 days before the deadline for submission of documents.

In the case of presentation of the above documents in a language other than Russian, Romanian or English, it is necessary to additionally attach a notarized translation into one of the above languages to each document.

Without fail, the original documents and their translation must be legalized by the Ministry of Foreign Affairs and apostilled in accordance with the official procedure of the respective country and submitted to the department for foreign students of CSU.
