Official languages of the conference: Romanian, English, Russian, and Gagauz.

To participate in the conference, participants must submit their completed paper formatted according to the requirements of the Organizing Committee no later than **December 1, 2025**.



Requirements for the report texts:

The volume of the submitted materials is 5–7 pages of A4 format, including tables, figures, graphs.

The text must be submitted in Word format in /Romanian /English /Russian /Gagauz languages, font Times New Roman, size 12, line spacing 1, margins of 20 mm on all sides. Paragraph indent – 1 cm.

References to the literary source should be indicated in the text in square brackets, the serial number of the source and the page are indicated. The bibliographic description must be arranged in the order of mention in the text.

On the first line in the left corner, the UDC is printed. After the UDC, on the next line in the center of the line, the title is printed in capital letters in bold font (size 12) and separated from the main text by one line. Below are printed the surnames and names of the authors, their academic degree and academic title, name of the organization/institution/enterprise, city, region, country, e-mail. **An abstract in English and in the language of the article (40–60 words) and keywords (5–10 words in English and in the language of the article).** Words in the text are printed without hyphenation, text alignment – justified.
